## SECTION 3. HAZARDS IDENTIFICATION:

Flammable. Concentrated product. Do not ingest, use good housekeeping procedures when handling.

## SECTION 4. FIRST-AID MEASURES:

INHALATION: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

## SECTION 5. FIRE FIGHTING MEASURES.

EXTINGUISHING MEDIA RECOMMENDED: Use CO<sub>2</sub>, Dry Powder or Foam type Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

SPECIAL MEASURES: Avoid vapor inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.

EXTINGUISHING PROCEDURES: Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

## SECTION 7. HANDLING & STORAGE.

PRECAUTIONS IN HANDLING: Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene, and do not eat, drink or smoke while handling.
